



## OFFICIAL RULES

**CONTEST NAME** « Happy Birthday to Moi » (the **Contest**)

**DATE** June 6 to July 3, 2024

- 1. ORGANIZER.** The contest is held by Metro Richelieu Inc.  
(individually and collectively the “**Organizer**” or “**Contest Organizer**”).
- 2. CONTEST PERIOD.** The Contest will run during the following period (“**Contest Period**”)

Date: June 6, 2024

Time: 00:01 Eastern Time (ET)

Contest End

Date: July 3, 2024

Time: 23:59:59 Eastern Time (ET)

### 3. ELIGIBILITY

The Contest is open to residents of Quebec, Ontario and New-Brunswick who are of the age of majority at the time of entry. To participate, you must be a member of the Moi program.

The following are excluded: directors, officers, executives, employees, agents and representatives of the Contest Organizer, its parent company, or any company, trust or other legal entity controlled by or affiliated with them, of Facebook if Contest is run on Facebook, of participating stores, advertising and promotional agencies, suppliers of prizes, partners in this contest, including RBC, goods and services related to this Contest, as well as members of their immediate families (brothers, sisters, children, father, mother, legal or common-law spouse, wherever they may reside) and the individuals with whom they reside (whether related or not).

#### 4. ENTRY / NO-PURCHASE-REQUIRED

**No purchase required to enter or win. A purchase does not increase odds of winning.**

The Contest will run in Moi program participating stores in Quebec, Ontario and New-Brunswick and online. **(the “Participating Stores”)**. Participating banners are listed in Appendix A to the Regulations.

**Moi member** — To enter, you have to be a Moi program member. If you are not a member, you can sign up on [www.moiprogram.ca](http://www.moiprogram.ca). Simply fill in the registration form, entering your first and last names, full address, phone number(s), birth date and email address. Choose a user name and password. If you are already a Moi member, make sure that the information you provided in joining the Moi program is up to date, and consent to having it used for this Contest.

**Entry** — Make a purchase in a Participating Store, presenting your Moi card at the time of purchase. The purchase must be for a minimum purchase of \$1 before taxes for instore purchases, and of \$50 before taxes (in one single transaction ordered, paid, and delivered) for online groceries, excluding tobacco products, alcoholic beverages, bus/metro tickets or passes, lottery tickets and gift cards. You will be automatically entered in the contest. Ensure that the information you have provided for registration in the Moi program, if applicable, is up to date and consent to its use in connection with this Contest.

If you don't have your Moi card on you, you must have your cash register receipt stamped at the service counter before leaving the store. You can return to the store, present the stamped cash register receipt and your Moi card at the service counter and ask that your points balance be adjusted and to be entered in the contest. Only stamped cash register receipts will be accepted.

**No-purchase entry.** To receive an entry form without purchase, hand-write a legible and original letter of at least 50 words explaining why you love the contest, including your full name, complete address including postal code, telephone number, e-mail address and Moi membership number, and mail it in an envelope with sufficient postage to : Service aux consommateurs, 11011 boul. Maurice-Duplessis, Montréal (Québec), H1C 1V3, to be received no later than July 3 2024, or postdated to that date. Your letter will be validated by a representative of the Organizer and your entry will be added to the database.

**Limit.** Entrants must respect the following limits, failing which they will be disqualified:

- **Entry with purchase:** One (1) entry per eligible member per day, per Participating Banners.
- **No-purchase entry:** One (1) entry per eligible Moi Program member per day.
- **Moi Program member with a moi RBC Visa credit card:** Moi Program members with a moi RBC Visa credit card linked to a valid Moi card during the Contest Period will automatically receive five (5) times the Contest entries for each purchase or no-purchase entry, provided that (i) all criteria set out in the box above are met depending on the method of entry, and (ii) the member complies with the entry limits set out above. For purchase-based entries, members are not required to pay for their purchases with their moi RBC Visa credit card in order to obtain their five (5) entries. The Organizer will be responsible for counting members' entries.

- Land, grading, filling, blasting if necessary, exceptional excavation, transport of excess earth, transport of snow, backfilling and landscaping. Please note that soil quality must be normal, and that Bonneville cannot be held responsible for any damage to the house resulting from soil unsuitable for a house on foundations. The site must be easily accessible to our trucks transporting the modules, via a public road that is passable and approved by Transport Québec.
- Hydro, Bell and cable charges
- Special tax, transfer or other
- Any other exceptional expenses
- Any expenses incurred due to soil composition requiring special tools, work or expertise
- All transportation and loading of material on another site

- Due to site conditions and soil quality, the use of gravel, sand or other materials may be necessary.

- Excavation and connection of services when the source is located on the other side of a public road, within 30'.
- Any other event deemed uncontrollable by Bonneville
- The winner must give Bonneville Industries five (5) months notice to deliver the house and six (6) months notice to complete the finishing on site.
- The installation and finishing of the house is included for a lot located 200km or less from Beloeil. In the event that the installation and finishing of the house is done beyond 200km, an additional amount of \$100 per km must be paid by the winner.

**Manufacturer's warranty only.** No warranty other than the prize manufacturer or suppliers shall be applicable. The Organizer's bears no liability relating to the prize once it is delivered.

**Prize conditions.** The prize is subject to the Prize Supplier's terms and conditions of use.

In the event that the house is delivered within a radius of more than 200 km from Beloeil, an additional premium must be paid by the winner for work done on site: (piles, joinery connection for modules, standard plumbing connection, standard electrical connection, balcony under the eaves of the entrance). Bonneville will assess this amount according to the distance and location to which the house is delivered.

## 6. DRAW

## 7. CLAIMING PRIZES

### Main prize house Bonneville :

To be declared a winner, a selected entrant must:

- a) be reached by phone or email, at the Contest Organizer's sole discretion, within five (5) days of the draw. Any selected entrant that the Organizer, having taken appropriate and reasonable measures, has not been able to reach within that time shall be disqualified, and there will be a new draw to award the prize. A selected entrant reached by email must reply according to the instructions therein, if any. Any prize notification email with an "undeliverable message" shall result in the entrant's disqualification and the selection of a new entrant;
- b) sign the Declaration and Release Form sent by the Organizer and return it to the Organizer within five (5) days of receipt;
- c) answer a mathematical skill-testing question correctly, without assistance or mechanical aid;
- d) provide photo ID, upon request and in a timely fashion;

The Bonneville Industries contact person and details will be specified on the release form signed by the winner. It will be the winner's responsibility to contact Bonneville Industries once the release form has been signed and submitted to Metro.

Failure to comply with the conditions set out in these Rules or to accept his/her prize will result in the selected entrant's disqualification. In which case, the Contest Organizer may, at its sole discretion, cancel the prize or draw again from among the remaining eligible entries until an entrant is selected and declared the winner. If no entrant is declared the winner in sixty (60) days following the initial draw, the prize will be cancelled.

Within two (2) to four (4) weeks of receiving the duly completed and signed Declaration and Release Form, the Contest Organizer will contact the winners with information on how to collect their prizes.

**Non-acceptance of the prize.** It is understood and agreed that in the event that the contest winner is deemed unable to complete the proposed project for any reason whatsoever, he/she may elect a lump-sum cash award of \$200,000. No other substitution will be made. The choice made by the customer at the time of awarding the prize will be final and without appeal.

Contest Organizer reserves its rights, at its own discretion, to cancel any entry if such Entry was made by purchasing a product or products which was/were later returned by the participant. Such participant will have the opportunity to enter the Contest using the “No purchase required entry” if the delay set in these Rules is respected. Incomplete, illegible, mutilated, fraudulent or deteriorated entries as well as entries containing printing or other errors or that have been tampered with, spoiled, modified, falsified, reproduced or illegally obtained shall be rejected. 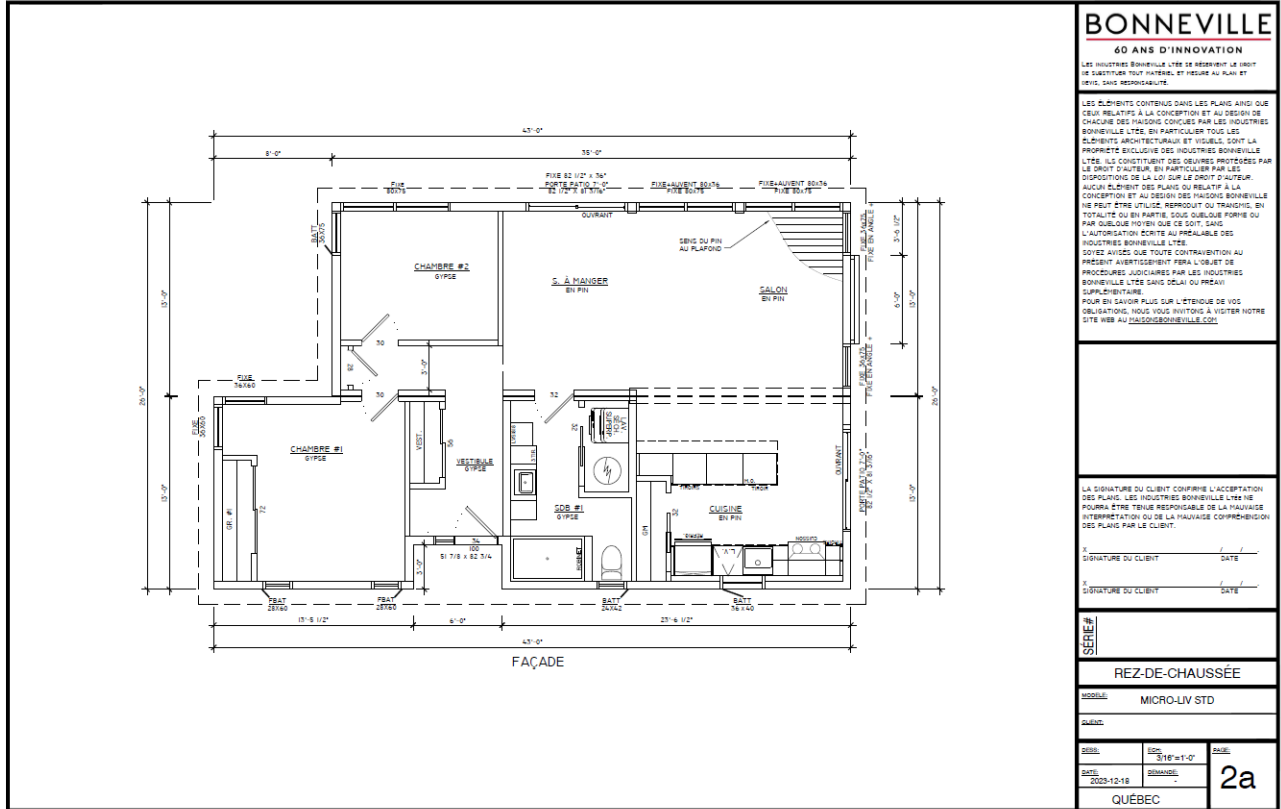
